2024 LEGISLATIVE COMMITTEE ACTIONS

VOTING ITEM R#2024-4, pg 9 -- Create an Exploratory Campus Ministry Fund Task Force

Legislative Committee 1 -- Chair: Rev. Jenaba Waggy Recorder: Rev. Carol Freeland

Amendment #1: Lines 7 and 8, delete "presented for consideration and vote to the Annual Conference." and replace it with "presented to the Annual Conference. If a vote on the plan is necessary, it shall be presented for consideration and vote." Then on lines 10-11 strike "for consideration and vote.

Amendment #1: Line 29, add a period after "Islamophobia." Move the remainder of the sentence to after "This can include" in the next sentence.

Amendment #1A: Add "recognizing" after "including" and delete "the celebration of"

Action on Amendment #1A: Yes - 130, No - 10 (amendment passed)

Line 29-31 then would read "Work toward eliminating Antisemitism and Islamophobia. This can include recognizing Jewish and Muslim holidays and the contributions of Jewish and Arab communities, including recognizing International

Holocaust Remembrance Week in January and Arab American Heritage Month each April."

Amendment #1B: Replace "Jewish and Arab" with "Israeli and Arabic"

Action on Amendment #1B: Yes - 33, No – 102 (amendment failed)

Amendment #1C: Delete everything after "Work toward eliminating Antisemitism and Islamophobia."

Action on Amendment #1C: Yes - 129, No -- 9 (amendment passed)

Line 29-31 then would read "Work toward eliminating Antisemitism and Islamophobia."

Action on Amended Amendment #1: Not taken

Amendment #2: Line 18, Add a new sentence after first sentence "In addition, we urge a letter of such support be sent to Benjamin Netanyahu explaining our position."

Action on Amendment #2: Yes - 33 No - 107 (amendment failed)

Final Action on Amended Resolution: Yes – 106 (75%), No - 35

Amendment #1: At the beginning of the resolution the following should be added:
"The Michigan United Methodist Annual Conference publicly supports the efforts of
Christians in the Holy Land who seek to help their neighbors understand their shared
heritage and to act for peace. We condemn the harm caused by the Israeli National
Government's political and military occupation and the resulting Apartheid conditions
imposed on Palestinians in the Occupied Territories."

AND

Line 11 before the word "and" add the words "13 Congressional representatives."

Action on amendment #1: Yes – 40, No – 135 (amendment failed)

Amendment #2: Lines 6, 15, and 22 – delete the words "the only" and replace with "a way to create a"

Action on amendment #2: Yes - 167, No - 8 (amendment passed)

Amendment #3: Add to line 26:

"Finally, we resolve that until lasting efforts toward peace are made, the Michigan Conference of the United Methodist Church will no longer support, advertise, or encourage Holy Land excursions, including but not limited to those trips promoted by and offered through Educational Opportunities Tours."

Action on amendment #3: Yes – 56, No – 108 (amendment failed)

Amendment #4: Line 14 – delete the word "aggressive" and replace with "diplomatic" Action on amendment #2: Yes – 156, No – 12 (amendment passed)

Final Action on Amended Resolution: Yes - 145 (85%) No - 25

Amendment #2A: Restore Line 27 and add at the end of line 27 "based on historic United Methodist teachings, Scripture, and the 2020/2024 Revised Social Principles."

Action on Amendment #2A: Yes - 97, No - 72 (amendment passed)

Action on Amended Amendment #2: Yes – 149, No – 20 (amendment passed)

Amendment #3: Delete lines 9 and 10

Action on amendment #3: Yes – 49, No – 115 (amendment failed)

Editorial change: Line 25, replace "League for Women Voters" with "League of Women Voters"

Lines 5 through 22 as printed in the 2024 Voting Items booklet Line 24 and follows to read:

"We urge Michigan United Methodists and friends to participate in Get Out the Vote (GOTV) with nonpartisan organizations such as the League of Women Votes, the NAACP.

"We urge Michigan United Methodists and U.S. citizens to ask nonpartisan questions to evaluate candidates based on historic United Methodist teachings, Scripture, and the 2020/2024 Revised Social Principles."

Therefore, Line 9 would read "first module should be completed by **Dec. 31**, 2024, and the second by Dec. 31, **2025**."
